**INVITATION TO BID FOR THE PROCUREMENT OF VARIOUS
REHABILITATION SUPPLIES OF PDL OF BJMPRO-I
FOR THE 2ND SEMESTER OF CY 2018 (RE-BID)**

1. The *Bureau of Jail Management and Penology Regional Office I (BJMRO-I)*, through the *General Appropriations Act of 2018* intends to apply the sum of Two Million Four Hundred Twenty Four Thousand Pesos and Ninety Five Centavos (P2,424,000.95) being the Approved Budget for the Contract (ABC) to payments under the contract for the *Procurement of Various Rehabilitation Supplies of PDL of BJMPRO-I for 2nd Semester CY 2018 (Re-bid)* with *ITB# 2018-09-31*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Bureau of Jail Management and Penology Regional Office I* now invites bids for the procurement of Various Rehabilitation Supplies (please refer to the attached item list). Delivery of the Goods is required within Ten (10) calendar days upon issuance of Notice to Proceed. Bidders should have completed, within Two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from *Bureau of Jail Management and Penology Regional office 1, Logistics Division* and inspect the Bidding Documents at the address given below during office hours at 8:00 am to 5:00 pm.
5. A complete set of Bidding Documents may be acquired by interested Bidders on September 10-29, 2018 at 8:00 am to 5:00 pm and October 01 at 8 am to 10 am from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php 5,000.00)*.



7. Bids must be duly received by the BAC Secretariat at the address below on or before **October 01, 2018 at 10:00 a.m.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
8. Bid opening shall be **on October 01, 2018 at 10:00 o'clock in the morning at BJMPRO-I Multi-Purpose Hall, Camp Florendo, Parian, San Fernando City, La Union.** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
9. The **BJMPRO-I** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
