1. Business Matters:

The Post Qualification for the above project held at BJMPRO-I, Multi-Purpose Hall, Camp Florendo, Parian, San Fernando City, La Union was called to order at **10:50 A.M. on March 21, 2019** by the BAC Vice Chairperson.

After confirming quorum and compliance with the prescribed requirement of inviting observers, the BAC Vice Chair acknowledged all persons in attendance, and then gave a brief background of the project.

The ABC of the above project is **Php. 4,383,650.00** and Ayscee Enterprises was declared as SCB having a Bid Price amounting to **Php. 2,997,451.00** and was subjected to Post-Qualification Evaluation.

2. Presentation of Post-Qualification Evaluation Report

JINSP MONINA G TANINGCO, the Head TWG for goods presented her Post-Qualification Evaluation report. She claimed to have verified, validated and ascertained all statements made and documents submitted by Ayscee Enterprises.

Having verified, validated and ascertained that all of the statements made and documents submitted were subsisting and authentic, the TWG declared Ayscee Enterprises to be compliant with and responsive to the requirements of the Procuring Entity and further recommended it to be declared as SCRB.


Based on the recommendation of the TWG, JCI ALFONSO moved for the adoption of the TWG report, for the declaration of Ayscee Enterprises as Single Calculated Responsive Bidder (SCRB) and for the recommendation to the HOPE the Award of the Contract to Ayscee Enterprises. The motion was seconded by JSI PANG-AG.

Having been moved and seconded, the Vice Chair ruled for the adoption of the TWG Post Qualification Evaluation Report, declaration of Ayscee Enterprises as SCRB and recommendation to the HOPE the award of the contract to the said bidder. He instructed the BAC Secretariat and TWG to prepare the BAC Resolution, the minutes and the notification to the bidder on the outcome of the proceedings.


3. Noted comment/reaction from the BAC:
