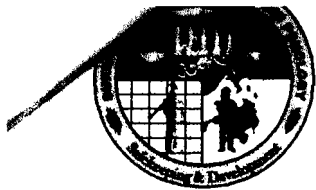

**COMMITTEE ON UNIFORM FOR JAIL OFFICER**  
**Resolution No. 2011-01**

**A RESOLUTION RECOMMENDING THE REPLACEMENT OF THE PRESENT GENERAL OFFICE ATTIRE (GOA) FOR JAIL COMMISSIONED OFFICERS (JCOs) AND NATIONAL EXECUTIVE SENIOR JAIL OFFICER (NESJO)**

**WHEREAS**, the **Committee** convened on 10 January 2011 to decide on the changes on the **General Office Attire (GOA)** for **Jail Commissioned Officers (JCOs)** and **NESJO**;

**WHEREAS**, after deliberation the **Committee** unanimously approved that the **General Office Attire (GOA)** for **JCOs** and **NESJO** shall be made with the textile material as that of the delta uniform presently in use;


**WHEREAS**, the design of the upper and lower garment shall undergo minor modifications wherein the proposed new upper garment shall have a flip top design (hidden button) similar with the upper garment of the **Bush Jacket** and the proposed lower garment shall feature a black biased tape piping on both sides;


**WHEREAS**, the black biased tape piping on both sides of **GOA's** lower garment will serve as a distinction to the lower garment of the **Bush Jacket** and in effect preclude personnel from using the same lower garment for **GOA** and **Bush Jacket**;

**WHEREAS**, the proposed change of **JCO's GOA** shall aptly aid in the proper distinction between a **Jail Commissioned Officer** and that of a **Jail Non-Commissioned Officer**.

**NOW, THEREFORE**, the **BJMP Committee on Uniform** has **RESOLVED, AS IT HEREBY RESOLVES** to recommend to the **Chief, BJMP** the approval of this Resolution.




