INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

The Bureau of Jail Management and Penology Regional Office 1 (BJMPRO-1), through its Regional Bids and Awards Committee (RBAC), invites contractors registered with and classified by the **Philippine Contractors Accreditation Board (PCAB)** and **Phil-GEPS** registered (**Platinum Membership**) Contractors to apply for eligibility and if found eligible, to bid for

Prospective bidders should possess a valid PCAB License applicable to the contract, have completed a similar contract with a value of at least 50% of the ABC, and have key personnel and equipment (listed in the Eligibility Forms) available for the prosecution of the contract. The BAC will use non-discretionary pass/fail criteria in the Eligibility Check/Screening as well as the Preliminary Examination of Bids.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulation (IRR).

The BAC will issue to prospective bidders Eligibility Forms and Bid Documents at BJMP Regional Office 1, after their submission of a LOI and upon their payment of a non-refundable amount of Twenty-Five Thousand Pesos (Php 25,000.00) to the BJMPRO-I Finance Service. Prospective bidders shall submit the Eligibility Requirements to the BAC at the said address. They may also obtain the results of the Eligibility Check by the BAC at the same address.

Eligibility and bid forms shall be accomplished in computerized form and must be contained in folders with complete tabbings chronologically arranged as per instruction to bidders (para 12) and submitted to the BAC Chairperson thru the BAC Secretariat.

The BAC reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract in any of the causes stated under Section 14 of RA 9184.

The procuring authority assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of their bids.
